

Every year since 1983, a team of volunteer medical professionals have made annual trips to Mexico, Central and South America to provide cleft lip and palate surgery for impoverished children. This year, they spent 10 days at work in Chihuahua, Mexico.

This dedicated group of doctors and nurses repaired cleft lips and palates of 42 children this year. These surgeries dramatically changed the lives of the patients and their families.

St. Mary's Clinic serves as a medical home for more than 14,000 patients. Every day vital healthcare services are delivered to patients in an under-served community. Sister Rosanne Popp, M.D. and her staff help break the cycle of poverty due to the inability to work because of illness.

A patient visited the clinic who was feeling very weak. He works in construction and does not have the luxury of taking off from work, because he is the sole breadwinner for his family. After his lab tests, we discovered he has Hepatitis C. We were able to offer him special services and refer him to a free Hepatitis C clinic. Since then, his Hepatitis C count is undetectable. He is feeling much better and can continue to provide for his family.


